## What is this product?

### Type

This product is an investment fund.

### Term

The Fund is established for an unlimited duration, with the possibility for the Board of Directors to decide the termination of the Fund at its sole discretion.

### Objectives

Liontrust European Sustainable Equities belongs to the category of Single Manager Funds.

The Fund seeks to increase the value of its assets over the long term by investing predominantly in transferable equity securities such as equities, other equity shares such as co-operative shares and participation certificates issued by, or warrants on transferable equity securities of, companies which are domiciled in or exercise the predominant part of their economic activity in Europe.

The minimum asset allocation in such securities on a consolidated basis (direct and indirect investments) will be of 60% of the Fund's net assets.

Moreover, the minimum Fund's investment in equity securities will be of 75% of the Fund's net assets.

Investments in debt securities will not exceed 15% of its net assets.

The Fund may invest for maximum 10% of its net assets in funds that have been selected in accordance with a number of qualitative and quantitative criteria.

**Sustainable Investment Policy** The Funds contributes to environmental and social objectives and qualifies as an investment product in accordance with article 9 of Regulation (EU) 2019/2088 on sustainability related disclosures in the financial services sector.

The environmental sustainable investment objective of the sub-fund is to invest in businesses which support the goal of net zero greenhouse gas emissions by 2050, in line with the external investment manager's Net-Zero Asset Managers Initiative (NZAMI) commitment and the goals of the Paris Agreement. In addition, as part of its social sustainable investment objective, the sub-fund invests in companies contributing positively to social solutions.

In that respect, The Fund will also focus of its efforts on issuers, which are positively exposed to three long-term sustainable themes such as (i) "better resource efficiency", (ii) "improved health" and (iii) "greater safety and resilience", while still providing long term capital appreciation. The Fund manager will use its proprietary ESG scoring system to select

those companies.. For this, all investments are examined for adverse impacts and adherence to global norms on environmental protection, human rights, labour standards and anti-corruption. The sustainability approach is designed to implement the Do Not Significantly Harm principle. The company should pass the exclusion rules of the Sustainable Investment Policy of the Management Company. The Fund Manager may implement other exclusions as well, and in that respect, the Fund manager will not invest in companies that have a strategic involvement in nuclear. The extra-financial process covered 100% of the portfolio (cash and derivatives are not covered by the ESG analysis). At least, 20% of the investible universe is reduced, after implementation of the sustainability filters.

Methodological limitations can be assessed in terms of: nature of ESG information (quantification of qualitative data), ESG coverage (some data are not available for certain issuers) and homogeneity of ESG data (methodological differences).

The derivative instruments are not covered by the ESG analysis.

### Derivative instruments

The fund may invest in derivative instruments for investment, efficient portfolio management or hedging purposes.

**Relation to the Reference Portfolio** This Fund is actively managed and is compared to the MSCI Europe TR Net for performance and risk level indicator purposes. However, the reference to this index does not constitute any objective or limitation in the management and composition of the portfolio and the Fund does not restrain its universe to the index components. The index does not evaluate or include its constituents on the basis of environmental and/or social characteristics and is therefore not aligned with the ESG characteristics promoted by the Fund.

Therefore returns may deviate materially from the performance of the reference index.

The base currency of the Fund is EUR.

Income is systematically reinvested.

Investors are able to redeem on a daily basis (on Luxembourg bank business days).

### Intended retail investor

This product is intended for investors who plan to stay invested for at least 5 years and are prepared to take on a medium level of risk of loss to their original capital in order to get a higher potential return. It is designed to form part of a portfolio of investments.

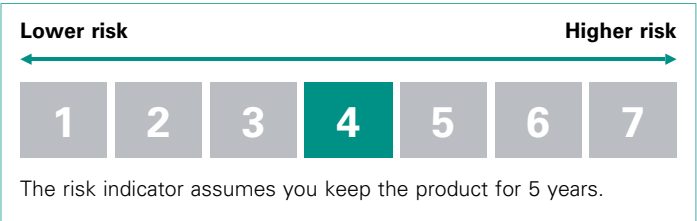

What are the risks and what could I get in return?

Risks



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

What happens if ABN AMRO Funds Liontrust European Sustainable Equities is unable to pay out?

If we are not able to pay you out what we owe you, you are not covered by any national compensation scheme. To protect you, the assets are held with a separate company, a depositary. Should we default, the depositary would liquidate the investments and distribute the proceeds to the investors. In the worst case, however, you could lose your entire investment.

Costs over time

- in the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario,
- 10,000 EUR is invested.

### How long should I hold it and can I take money out early?

#### Recommended holding period: 5 years

This product is designed for longer term investments; you should be prepared to stay invested for at least 5 years.
